



Declaration of Conformity to REACH Regulation (EC) 1907/2006

Fritsche GmbH & Co. KG is a manufacturer of fittings for central lubrication systems, hose and pipe assemblies, fastening material as well as various accessories in the field of lubrication technology. According to the REACH regulation, our company is thus considered as a downstream user of articles and is neither obliged to register nor to prepare safety data sheets.

According to Article 33 of the REACH Regulation, we are subject to a duty to inform about substances of very high concern (SVHC), which are contained in our articles with more than 0.1 mass percent according to the candidate list. Therefore we are in constant contact with our suppliers.

The Fritsche GmbH & Co. KG declares that some of its products may contain lead (**CAS No. 7439-92-1**) with a content of more than 0.1 mass percent. However, this does not create the need for special conditions of use, as all products are intended for industrial use and not for prolonged direct contact with humans. In addition, no substances can be intentionally released during the ordinary use of the finished products. Our grease-filled hose assemblies may also contain the following substances at more than 0.1% by mass: **Dilithium azelate (CAS No. 38900-29-7); ZnDTP (CAS No. 4259-15-8); organ. Polysulfide (CAS No. 68937-96-2); base oil (CAS No. 64742-55-8); aromatic amine (CAS No. 68411-46-1); Ca-sulfonate (CAS No. 1471316-72-9).**

We confirm that no other substance from the current candidate list (SVHC list <http://echa.europa.eu/de/candidate-list-table>) is contained with more than 0.1 mass percent in our products.
